## ORDER

As per the G.O. read above, sanction has been accorded for the release of the fourth installment of 6th UGC pay revision arrears to the College/University teachers. The Accountant General, Kerala, pointed out that excess payment was made to the teachers by the Universities for valuation of answer scripts of regular students, which has to be performed as part of the normal duty of the teachers as per the guidelines issued by the UGC. Hence, it is incumbent upon the State to recover such excess amount from the arrears due to the teachers.

Considering the fact that some more time is required to quantify the exact amount to be recovered from the teachers, it is hereby ordered to release only 80% (Eighty percentage only) of the arrears and to hold back the remaining 20% of the amount ordered for release as per G.O. read as first paper above.

The Registrar, the Finance Officer and the Controller of Examinations of each University, in consultation with the Accountant General, shall quantify the excess amount recoverable from each faculty member, who received remuneration for valuation of answer scripts of regular students, against which the Accountant General raised objection as irregular payment. This process shall be completed within a period of three months from the date of issuance of this order.
